



RELEASE OF LIABILITY

READ CAREFULLY – THIS AFFECTS YOUR LEGAL RIGHTS

In exchange for Participation in the activity of **Driving Off-road in an Overland Experience with Camping**, organized by **Looney Jeep Adventures**, located at **1970 N Leslie St. #422, Pahrump, NV 89060** and or use of the property, facilities and services of Looney Jeep Adventures, I agree for myself, and (if applicable) for any minor children of which I am the parent or legal guardian of, to the following:

1. AGREEMENT TO FOLLOW DIRECTIONS. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions or directions given by **Looney Jeep Adventures** or the employees, representatives, volunteers or agents of Looney Jeep Adventures.
2. ASSUMPTIONS OF THE RISKS AND RELEASE. I recognize that there are certain inherent risks associated with the above describes activity and I voluntarily assume full responsibility for personal injury to myself and (if applicable) my family members or passengers with me and further release and discharge **Looney Jeep Adventures**, for injury, loss or damage arising out of me or my family or passengers use of or presence upon the facilities of my selective tour, whether caused by the fault of myself, my family, my passengers or **Looney Jeep Adventures** or other third parties. This including fatigue, small injuries, disabilities, or even death,
3. INDEMNIFICATION. I agree to indemnify and defend **Looney Jeep Adventures** against all claims, caused of action, damages, judgments, costs, or expenses, including attorney fees and other litigation costs, which may in any way arise from me or my family or passengers use of, or presence upon an area or property regarding **Looney Jeep Adventures**. 4. FEES. I agree to pay for all damages to the facilities or properties provided by **Looney Jeep Adventures** caused by any negligent, reckless, or willful actions by me, my family, or passengers.
5. MEDICAL AUTHORIZATION. In the event of an injury to a participant during the above-described activities, I give my permission to Looney Jeep Adventures or the employees, representatives, volunteers, or agents of **Looney Jeep Adventures** to arrange for all necessary medical treatment. I also signify that by signing this waiver, the participant warrants that they have proper insurance to participate in the selective tour.  - A. The power to seek appropriate medical treatment or attention on behalf of my child as may be required by the circumstances, including without limitation that of a licensed medical physician and or hospital.
 - B. The power to authorize medical treatment or medical procedures in an emergency situation and
 - C. The power to make appropriate decisions regarding, clothing, bodily nourishment and shelter.
6. APPLICABLE LAW. Any legal or equitable claim that may arise from participation in the above activities shall be resolved under Nevada law.

7. NO DURESS: I agree and acknowledge that I am under no pressure or duress to sign this Agreement and that I have been given a reasonable opportunity to review and acknowledge that I am under no pressure or duress to sign this Agreement.

9. I acknowledge that engaging in this activity may require a degree of skill and knowledge different than other activities and that I have responsibilities as a participant. Participant is consenting to the exclusive jurisdiction of the federal state courts of Nevada.
